- Cancellation must be received in writing by August 31, 2019 for refund
- If on Franklin St., the sidewalk must be kept clear and all hoses/cords covered
- Fee is \$24/ft. for Franklin St. and \$22/ft. for Burton St. and P-Lot with a minimum of \$300, except Tate Park which is \$100 for Saturday only
- Parking for food vendors is available at the water tower only. No special arrangements will be made.
- Vendors will be notified of the event staging, set-up and tear down location/times at a later date
